To qualify for membership in the VFW you **MUST** meet the following **TWO** requirements:

1: Honorable Service – must have served in the Armed Forces of the United States and either received a discharge of Honorable or General (Under Honorable Conditions) or be currently serving.

2: Service in a war, campaign, or expedition on foreign soil or in hostile waters*. This can be proven by any of the following:

- An authorized campaign medal (see a full list of qualifying ([//vfw-org-hqagarhxahbybyd9.z01.azurefd.net/-/media/VFWSite/Files/Join/One-PageEligibilitySheet.pdf?la=en&v=1&d=20241021T210254Z](https://vfw-org-hqagarhxahbybyd9.z01.azurefd.net/-/media/VFWSite/Files/Join/One-PageEligibilitySheet.pdf?la=en&v=1&d=20241021T210254Z)) medals and badges)
- Receipt of Hostile Fire Pay or Imminent Danger Pay (verified by a military pay statement)
- Service in Korea for 30 consecutive or 60 non-consecutive days

Harry Donovan Fairlawn VFW Post 349

1. Monthly meeting on the 4th Monday of each month at 10:00am. We meet at the Fairlawn Kiwanis Community Center, 3486 S. Smith Road, Fairlawn, OH 44333-if a meeting has to be changed the members are notified via e-mail.
2. We distribute Poppies, for donations, the weekend closest to Memorial Day and Veterans Day.
3. On Memorial Day we conduct a Service with the City of Fairlawn at the Fairlawn Bicentennial Park to honor those who made the ultimate sacrifice.
4. During the holiday season in December, we visit local Nursing homes with a Barbershop Quartet.
5. From November 1 thru the 11th we conduct a daily ceremony at the Fairlawn Bicentennial Park (the Park is located next to the Fairlawn Kiwanis Community Center). Warrior's Journey Home initiated the Witness Tree project, the purpose of which is to bring attention to the 22 veterans who commit suicide daily, two years ago, and we are one of 4 locations conducting the daily observance.
6. We raise between \$20,000.00 and \$25,000.00 annually which is available to distribute to Veterans Organizations. We have no overhead, so all funds raised are distributed.
7. Monthly we send out Post information via email.
8. Periodically we have a Post educational meeting, which we invite the community to attend.

Note: There is no requirement that Members participate in the above events, they do so as they are able.
